Who is the qualification for?

Under the Licensing Act 2003, there is a legal requirement for anyone selling alcohol, or authorising others to sell alcohol, to obtain a qualification that has the accreditation of the Secretary of State. What does the assessment involve?

Assessment for the qualification is a 1 part, 40 question multi choice examination, with 40 minutes allowed for completion. 28 out of the 40 questions must be answered correctly.
